



## President's Annual Report 2024-2025 Fiscal Year Highlights

### Major New Projects/R3 Items Completed:

#### Recreational Events:

Our 4<sup>th</sup> of July and Labor Day events were outstanding as well as our social gathering movie nights. Our 4<sup>th</sup> of July celebration included games for the whole family, a BBQ, and an outstanding Fire Works Display. The lake was very clear this year with minimal weeds and a good flow. We were unable to get fish this year for planting in the lake. So, we did not have a fishing derby. RV sites usage has been put on hold as of August 1<sup>st</sup> for new reservations for the 2024-2025. And will be temporarily put on hold if no Camp Host is available for the coming 2025-2026 Season. Firewise certificate was not updated and will be updated in November 2025 which is the renewal date to put in the application.

To help with the “lack of volunteers”, the Board continued the unpaid position of “Pinebrook Staff Member” to help with new project and maintenance efforts as well as social events.

The Pinebrook Board will continue to focus on a calendar of events that attracts participation. A lack of volunteers to drive and make these events happen is a continual challenge.

#### Summary Report:

We will continue to focus on maintaining and improving our recreational facilities and offering social events that will provide entertainment, participation and fellowship. We are challenged with increasing costs, while trying to keep our operating costs and Annual Dues low. It is difficult to offer facilities and services that will meet a demand of 3 or 4 crowded days a year. A small number of volunteers continue to manage the organization and facilities maintenance & development. Volunteers to be Board members and help with social events are always needed. With the loss of Mike Coffee and Dale Pilgeram these past two years, the annual assessment finally has to increase. We already feel the effects of what Dale predicted. The Annual dues will be as follows **\$315.** for improved lots & **\$185.** for bare lots. The annual fee for Use Fee Members (U.F.M.) to **\$415.** for the year. For 25-256 that will hopefully be enough.

While crime continues at a lower rate in our area and community than in the past. We need to stay diligent in protecting our property and reporting suspicious activities, vehicles, and people.

Many new families joined our community this year along with a number of retiring folks with visiting grandkids. It is great to see a continued increase in families taking advantage of our facilities.
